This release is intended to discharge in advance the City of Avon, its officers, employees and agents from any and all liability arising out of or connected in any way with my participation in activities at this or any other Avon Parks and Recreation facility even though that liability may arise out of negligence or carelessness on the part of those parties. It is understood that activities such as the ones I will be participating in involve an element of risk and danger of accidents and knowing those risks, I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold harmless, the City of Avon, its officers, employees and agents from any loss, liability, damage, cost or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in any activity at this or any other Avon Parks and Recreation facility. I understand that by participating all Participants consent to photo images taken by the Avon Parks and Recreation staff during this activity to be used in any or all Avon Parks and Recreation publications and websites. I hereby consent that the participant may participate in activities at this, or any other Avon Parks and Recreation facility and I hereby execute the Agreement, Waiver and Release on his/her behalf. I hereby affirmatively state that the said Participant is physically able to participate in said activity. I hereby agree to indemnify and hold the persons and entities mentioned above free and harmless from any loss, liability, damage, cost or expense that they may incur as result of the death or any injury or property damage that said participant may sustain while participating in activities at any such Avon Parks and Recreation Department

CITY OF AVON COVID-19 USER AGREEMENT & WAIVER, on behalf of myself and my minor child(ren) state the following: I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines and the Ohio Health Department ("OHD") orders and best practices regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day. I accept full responsibility for familiarizing myself with any changes to the OHD orders and best practices and CDC guidelines. Notwithstanding the risks to me and/or my minor child(ren) associated with COVID-19, which I readily acknowledge, I hereby willingly choose to engage and allow my child(ren) to engage in activities at City of Avon facilities, including, but not limited to, the Avon Isle, Avon Lions Community Center, and all park property including pavilions within the City of Avon. I will follow, and see that my child(ren) follows the applicable laws and guidelines while utilizing City of Avon facilities. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my use of the recreation facilities and/or attendance at any event held at any recreation facilities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the City of Avon, its officials, elected or otherwise, agents, employees, contractors, and assigns (the "RELEASEES") from any liability related to COVID-19 which might occur as a result my utilizing the recreation facilities and/or attending any event held at any recreation facilities. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury to me or my child(ren). This Waiver and Hold Harmless Agreement shall bind any assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of Ohio. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT TO PERMISSION GRANTED BY RELEASEES TO USE THE RECREATION FACILITIES AND/OR ATTEND ANY EVENT HELD AT RECREATION FACILITIES. IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Wavier of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same.

2022 Avon Aquatic Facility Membership & Admission Guidelines

- Early Bird, Regular Rate and Renewal memberships are for Avon residents and ITW's (Avon Income Tax Workers)
- Proof of Avon residency or Avon Income Tax Worker is required (see below for required documents)
- Memberships are processed based on household address. All persons on the membership must reside at the same address and be immediate family. Immediate family is defined as the head of households spouse/partner and their child(ren) of which they are legally guardian.
- Seniors are defined as ages 60+
- Silver Sneakers and Renew Active/United Health Care are accepted, Avon Form must be completed each year (click here for form)
- Nanny Pass must be purchased by employing family at Avon Parks & Rec. Dept.

How to purchase your membership(s)??

RESIDENT NEW MEMBERSHIP(S):

- Purchase at Avon Parks & Recreation Dept. 35001 Schwartz Rd.; M-F 7:30am-3:30pm OR at the AAF cashier's office once pool is open
- Proof of Residency required (2 forms): Driver's License & Utility Bill or Rental Agreement)
- Proof of Household required for children (birth certificate or school report card)

RESIDENT RENEWAL MEMBERSHIP(S): RESIDENT PASSHOLDER from 2019,2020 or 2021

- Renew online at <http://avonrec.activityreg.com> or In-Person at Avon Parks Dept. If you are looking to add or remove a membership from past years or your address needs to be updated you must renew in-person at the Parks & Rec. Dept.- Online renewals can only be done for memberships that have no changes to your account. If you have questions on your renewal please feel free to call us 440-937-6106.

ITW MEMBERSHIP(S): NEW OR RENEWAL

- Purchase ONLY at Avon Parks & Recreation Dept. 35001 Schwartz Rd.; M-F 7:30am-3:30pm. Not available for purchase at the Aquatic Facility or online
- Proof of Employment required (pay stubs must be within the last 30-45 days); Letter from the employer or business card/business I.D. will NOT be accepted
- Proof of Household required for children (birth certificate or school report card), must be the legal guardian of children
- I.D. required (Driver's License)

Other ITW Membership Guidelines:

- Any ITW under the age of 18 may only purchase a single membership
- Privileges to bring in guests will be restricted to Adult ITW's only

DAILY ADMISSION & GUEST PASSES:

- Daily admission available for Avon Residents and ITW's
- Resident, ITW or Pass Holder can bring a guest (limit 2)
- ITW'S must be 18 to bring a guest

*Adult Pass Holders are responsible for their guest while visiting the Avon Aquatic Facility. They must comply with facility rules and regulations. Misbehavior of guests and/or pass holders can be cause for revocation of guest privileges and/or membership to the Avon Aquatic Facility.
