

ORDINANCE NO. 37-24

**AN ORDINANCE DESIGNATING PARK LANDS LOCATED ON
THE FORMER TRAXLER FAMILY LIMITED PARTNERSHIP
PROPERTY AS THE "TRAXLER FAMILY ARBORETUM"
AND DECLARING AN EMERGENCY**

WHEREAS, the City of Avon has acquired approximately 37.50 acres of land from the Traxler Family Limited Partnership located on Stoney Ridge Road for use as a public park pursuant to Ordinance No. 71-21 which passed on September 13, 2021; and

WHEREAS, to acknowledge the family for their willingness to allow the City to purchase the property to preserve park land, the name of this park will be known as the Traxler Family Arboretum; and

WHEREAS, Council agrees to officially name the park Traxler Family Arboretum and finds that doing so is in the best interests of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the lands acquired by the City for park purposes located on Stoney Ridge Road formerly known as the Traxler Family Limited Partnership property is hereby designated and officially named the "Traxler Family Arboretum". (See attached Exhibit A)

Section 2 - That all references to this park land, including, but not limited to, maps and all other official documents, shall bear the designation, identification and name: Traxler Family Arboretum. The Codifier shall insert this designation into the Avon Codified Ordinances as Section 1064.07.

Section 3 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Ordinance were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to officially declare and name the property referenced herein as the "Traxler Family Arboretum"; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

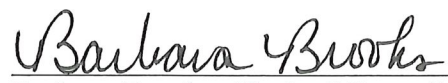

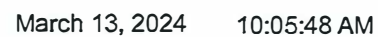

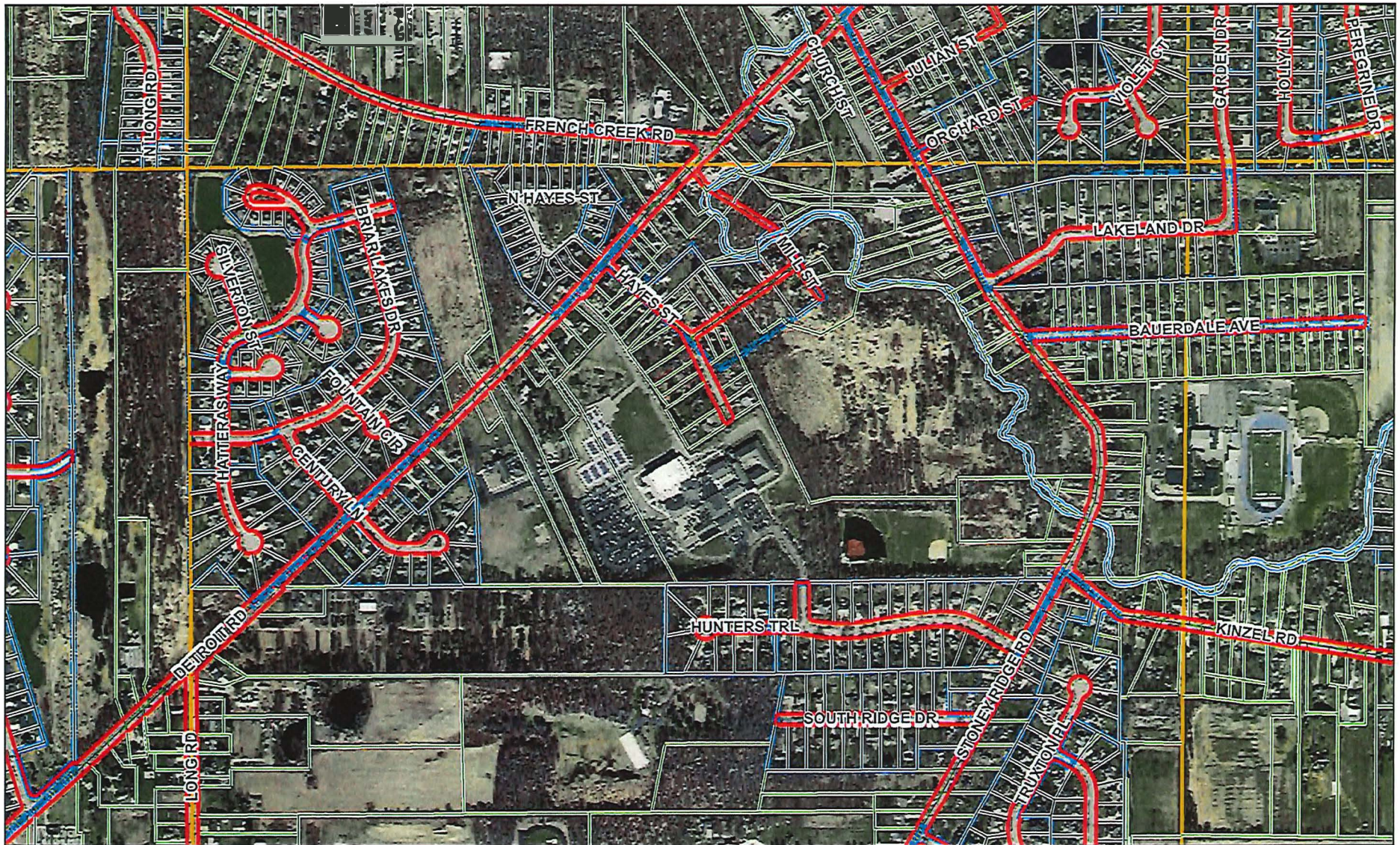
