

**RESOLUTION NO. R-24-24**

**A RESOLUTION TO ADVERTISE FOR BIDS FOR THE AVON POLICE  
DEPARTMENT VEHICLE TOWING AND STORAGE CONTRACT  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the towing and storage contract under which the Avon Police Department currently operates will expire before the end of the year; and

**WHEREAS**, the Safety Director, together with the Chief of Police of the Avon Police Department, determined that it is necessary to advertise for bids prior to entering into a new contract with a towing and storage company for these services; and

**WHEREAS**, Council, having reviewed the request, deems it in the best interests of the health, safety, and welfare of the citizens of Avon that the City move forward with advertising for bids for a new towing and storage contract to be utilized by the Avon Police Department.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:**

Section 1 - That the Safety Director, on behalf of the Avon Police Department is hereby authorized to advertise for bids for the City's new towing and storage contract pursuant to plans and specifications developed by the Avon Police Department which are incorporated herein by this reference and are on file and open for inspection at the Office of the Clerk of Council and at the Avon Police Department.

Section 2 - That the City shall reserve the right to reject any and all bids.

Section 3- That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4- That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety, and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to advertise for bids for a towing and storage contract for the Avon Police Department as the current contract will expire before the end of the year; therefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
