

RESOLUTION NO. R-27-24

**A RESOLUTION TO RE-SCHEDULE COUNCIL'S SECOND REGULAR MEETING
IN THE MONTH OF DECEMBER, 2024, CURRENTLY SCHEDULED FOR
MONDAY, DECEMBER 23, 2024, TO MONDAY, DECEMBER 16, 2024,
IMMEDIATELY FOLLOWING THE WORK SESSION OF COUNCIL
AND DECLARING AN EMERGENCY**

WHEREAS, this year Christmas Eve and Christmas fall on Tuesday, December 24th & Wednesday, December 25th, 2024, respectively; and

WHEREAS, to avoid conflicting with vacation and/or personal holiday plans of the general public, members of Council, and city officials, Council deems it advisable to amend Avon Codified Ordinance Section 220.01 to move the second Regular meeting in the month of December, 2024, currently scheduled for Monday, December 23, 2024 to Monday, December 16, 2024 immediately following the Work Session of Council.

WHEREAS, Council deems it in the best interest of the health, safety, and welfare of the citizens of the City of Avon that Council's December 23, 2024, regular session of Council be rescheduled as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

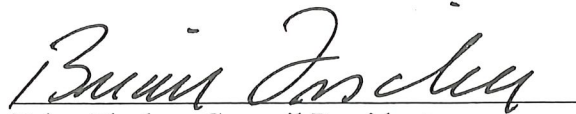
Section 1 - That the Avon City Council hereby amends Avon Codified Ordinance 220.01 (also known as "Council Rules") and reschedules the second Regular meeting in the month of December, 2024 from Monday, December 23, 2024, to Monday, December 16, 2024, immediately following the Work Session of Council. This amendment applies only to the month of December, 2024.

Section 2 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend Council Rules to reschedule the second Regular meeting in the month of December, 2024 from Monday, December 23, 2024 to Monday, December 16, 2024 immediately following the Work Session of Council; therefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.

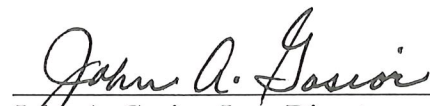

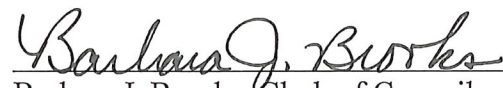

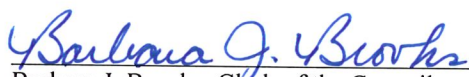
