

ORDINANCE NO. 118-24

**AN ORDINANCE TO AMEND SECTION 1073.03(b) OF THE
CODIFIED ORDINANCES OF THE CITY OF AVON TO INCREASE
FEES FOR THE USE OF AVON ISLE
AND DECLARING AN EMERGENCY**

WHEREAS, the Mayor and the Recreation Coordinator have reviewed the rental rates for Avon Isle; and

WHEREAS, owing to the increase in operating expenses for this facility, it was determined that Section 1073.03 should be amended to address these issues; and

WHEREAS, Council, having reviewed the proposed amendments, finds them to be appropriate and in the best interests of the health, safety, and welfare of the citizens of Avon and should be adopted.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1– That Section 1073.03(b) which currently reads as follows:

(b) The following fees and deposits for use of Avon Isle shall be paid at the time of issuance of the required permit by the permit holder. Deposit is due with completed contract to reserve date. Hourly fees are due at the time of completion of the contract or sixty days prior to date of the event. Failure to timely pay hourly fees will result in loss of the venue and forfeiture of the deposit.

Shall be amended to read as follows: (New language in bold print; deleted text stricken)

(b) The following fees and deposits for use of Avon Isle shall be paid at the time of issuance of the required permit by the permit holder. Deposit is due with completed contract to reserve date. Hourly fees are due at the time of completion of the contract or sixty days prior to date of the event. Failure to timely pay hourly fees will result in loss of the venue and forfeiture of the deposit.

Section 2 -That this ordinance, once passed by City Council, shall not become effective until January 1, 2025.

Section 3 - The Codifier is hereby instructed to insert the amendments into the Codified Ordinances of the City of Avon as set forth herein. All other language contained in Section 1073.03(b) not specifically amended herein shall remain in full force and effect.

Section 4 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in

such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend Section 1073.03(b) to provide for increases in fees for Avon Isle to be effective on January 1, 2025; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
