

RESOLUTION NO. R-22-25

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY
THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES
AND CERTIFYING THEM TO THE COUNTY AUDITOR
AND DECLARING AN EMERGENCY**

WHEREAS, Council, in accordance with the provisions of the law, has previously adopted a Tax Budget for the next succeeding year commencing January 1, 2026; and

WHEREAS, the Budget Commission of Lorain County, Ohio has certified its action thereon to this Council, together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council and what part thereof is within and what part is outside the Ten Mill tax limitation; and

WHEREAS, Council finds that after reviewing the determinations made by the Budget Commission, acceptance of same would be in the best interests of the health, safety, and welfare of the citizens of Avon, Ohio.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 – That the amounts and rates, as determined by the Budget Commission in its certification, be, and the same are hereby accepted. See Exhibit A attached hereto and incorporated herein by this reference.

Section 2 – That there is hereby levied on the tax duplicate of the City of Avon the rate of each tax necessary to be levied within and outside the Ten Mill limitation as set forth in the attached "Schedule A" which is made a part of this Resolution by reference.

Section 3 – That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 – That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of Avon, the immediate emergency being the necessity to accept the necessary tax levies as certified to the County Auditor in compliance with Ohio Revised Code; therefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
