

ORDINANCE NO. 50-15

**AN ORDINANCE TO AMEND ORDINANCE NO. 413-68, PASSED JANUARY 15, 1969
COMMONLY KNOWN AS THE ZONING ORDINANCE OF THE CITY OF AVON,
OHIO, AS AMENDED, REZONING TWO (2) PARCELS OF LAND CONSISTING OF
APPROXIMATELY 17.46 ACRES (TOTAL) LOCATED AT 34925 CHESTER ROAD,
PERMANENT PARCEL NOS. 10-04-00-021-000-266 AND 10-04-00-021-000-255 FROM
O-2 PLANNED RESEARCH OFFICE PARK TO O-2/C-4 PLANNED RESEARCH
OFFICE PARK/GENERAL BUSINESS DISTRICT OVERLAY**

WHEREAS, an application to rezone approximately 17.46 acres of land located at 34925 Chester Road, located in an O-2 Planned Research Office Park to O-2/C-4 Planned Research Office Park/General Business District Overlay was submitted to Planning Commission pursuant to Article VII, Section 2(d) of the Avon City Charter; and

WHEREAS, the Planning Commission, on March 18, 2015, held a Public Hearing on said amendment; and

WHEREAS, on March 18, 2015, the Planning Commission reviewed the proposed amendment to rezone these parcels of land as further described herein and considered the public comments and presentations of all interested parties and by a vote of four (4) in favor and zero (0) opposed recommended the amendment to Ordinance No. 413-68 to allow approximately 17.46 acres of land located at 34925 Chester Road, currently in an O-2 Planned Research Office Park to be rezoned to O-2/C-4 Planned Research Office Park/General Business District Overlay; and

WHEREAS, Council, on April 13, 2015, authorized a Public Hearing; and

WHEREAS, said Public Hearing was duly publicized according to law and was held on May 11, 2015 at 7:15 P.M.; and

WHEREAS, notice of the time and place of such Public Hearing has been given to record title holders of property immediately adjacent to, adjoining and abutting on such area, zone, or district proposed to be modified.

WHEREAS, Council finds that the recommendation of Planning Commission is reasonable and in the best interests of the safety, health and welfare of the City and deems it desirable that Ordinance No. 413-68 be amended to rezone a portion of land consisting of approximately 17.46 acres at 34925 Chester Road, currently in an O-2 Planned Research Office Park to be rezoned to O-2/C-4 Planned Research Office Park/General Business District Overlay.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That Ordinance No. 413-68, passed January 15, 1969, commonly known as the Zoning Ordinance of the City of Avon, Ohio, as amended, shall be further amended as provided hereafter.

Ordinance No. 50-15 (Con't.)

Section 2 - That from the effective date of this Ordinance, an area of land, made-up of approximately 17.46 acres located at 34925 Chester Road and consisting of Permanent Parcel Nos. 10-04-00-021-000-266 and 10-04-00-021-000-255 and more fully described in Exhibit A, is hereby rezoned from O-2 Planned Research Office Park to be rezoned to O-2/C-4 Planned Research Office Park/General Business District Overlay.

Section 3 - That all provisions of Ordinance No. 413-68 and its various amendments, shall remain in full force and effect.

Section 4 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5 - That this Ordinance shall take effect and be in force at the earliest date allowed by law.
