

ORDINANCE NO. 25-14

**AN ORDINANCE TO ESTABLISH COMPENSATION FOR
THE POSITION OF ECONOMIC DEVELOPMENT COORDINATOR/
ASSISTANT PLANNING COORDINATOR FOR THE CITY OF AVON
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Ordinance No. 24-14, Council established the position of Economic Development Coordinator/Assistant Planning Coordinator; and

WHEREAS, Council must establish compensation for said position; and

WHEREAS, the Administration recommends that the starting pay for this position in the year 2014 be set at between Sixty Thousand (\$60,000.00) and Seventy Thousand (\$70,000.00) Dollars; and

WHEREAS, Council, upon recommendation of the Administration, finds adoption of the compensation range being proposed for the position of Economic Development Coordinator/Assistant Planning Coordinator to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining well-qualified, efficient and productive Economic Development and Planning staff for the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That the Economic Development Coordinator/Assistant Planning Coordinator, upon being hired by the Mayor, shall receive a fixed salary, to be determined by the Mayor, between the range of Sixty Thousand (\$60,000.00) and Seventy Thousand (\$70,000.00) Dollars for the year 20014, said amount to be prorated from the date of hire to the end of the year. In addition, said employee shall receive all other benefits of a full-time, non-bargaining unit employee.

Section 2 - That the Finance Director is hereby authorized to appropriate funds necessary to meet the compensation established for this position within the range set forth in Section 1, above.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of

Avon, the immediate emergency being the necessity of establishing compensation for the Economic Development Coordinator/Assistant Planning Coordinator in order to maintain a well-qualified, efficient and productive Economic Development and Planning staff; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
