

RESOLUTION NO. R-14-13

**A RESOLUTION TO ADVERTISE FOR BIDS FOR THE
CONSTRUCTION OF AN ASPHALT PARKING LOT AT AVON ISLE
LOCATED AT 37089 DETROIT ROAD, AVON, OHIO
AND DECLARING AN EMERGENCY**

WHEREAS, the newly renovated Avon Isle is part of the City's public park system and is rented by individuals and groups for various family and civic functions; and

WHEREAS, the existing gravel parking lot is in need of a major upgrade to a paved, asphalt surface to make it safer for guests who attend these functions to enter and exit the facility; and

WHEREAS, the City contracted with Zwick Associates, Inc. to prepare plans and specifications for this renovation and it is now necessary to advertise for bids for the construction of a paved asphalt parking lot, together with appurtenances thereto, at Avon Isle located at 37089 Detroit Road in the City of Avon.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the City is hereby authorized to proceed with the advertisement for bids pursuant to law for the construction of an asphalt parking lot at Avon Isle, located at 37089 Detroit Road in the City of Avon, pursuant to plans and specifications prepared by the Zwick Associates, Inc. which are on file with the Office of the Clerk of Council and made a part of this Ordinance by reference herein.

Section 2 - That the City shall reserve the right to reject any and all bids.

Section 3 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution took place in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to advertise for bids for the construction of improvements at Avon Isle, 37089 Detroit Road; therefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
