

ORDINANCE NO. 131-15

AN ORDINANCE TO ACCEPT IMPROVEMENTS MADE BY JG AVON, LLC FOR THE CONSTRUCTION OF HEALTH CAMPUS BOULEVARD AS A PUBLIC ROAD, EAST OF NAGEL ROAD, OPPOSITE LEAR INDUSTRIAL PARKWAY BETWEEN CLEVELAND CLINIC BOULEVARD AND KREBS ROAD AND DECLARING AN EMERGENCY

WHEREAS, the owner, JG Avon, LLC, has constructed Health Campus Boulevard as a public road, east of Nagel Road, opposite Lear Industrial Parkway between Cleveland Clinic Boulevard and Krebs Road; and

WHEREAS, said improvements have been inspected by the City's Engineer, who has certified that said improvements have been constructed in accordance with the terms set forth in the Developer's Agreement and in conformance with City Development Regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That the City of Avon, Lorain County, Ohio, hereby accepts the construction of Health Campus Boulevard, a public road located east of Nagel Road, opposite Lear Industrial Parkway between Cleveland Clinic Boulevard and Krebs Road constructed by the Developer, JG Avon, LLC, subject to the Developer meeting all conditions set forth in Section 2 below.

Section 2 - The City's acceptance of dedication of the public road improvements herein is contingent upon the Developer providing the City with the following: (1) A Three (3) Year Maintenance Bond or similar Financial Guarantee for said improvements in the amount of Seventy Two Thousand Four Hundred Seventy Eight and 19/100 (\$72,478.00) Dollars; (2) a cash deposit in the sum of One Thousand Five Hundred and 00/100 (\$1,500.00) Dollars to cover miscellaneous costs incurred by the City relating to this Development; and (3) a license agreement to cover construction, operation and maintenance of those items listed therein that are located in the median strip of Health Campus Boulevard (attached hereto and incorporated herein as Exhibit A) Upon compliance with all the requirements set forth herein, the Finance Director shall release all financial guarantees of performance deposited or posted by the developer, its surety or lending institution with the City of Avon.

Section 3 - Upon recommendation of the Law Director and the City Engineer, the Finance Director shall authorize the release of all or part of deposits for legal and engineering fees set forth in the Developer's Agreement.

Section 4 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to accept the construction of Health Campus Boulevard, a public road located east of Nagel Road, opposite Lear Industrial Parkway between Cleveland Clinic Boulevard and Krebs Road constructed by the Developer, JG Avon, LLC; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
