

ORDINANCE NO. 52-17

**AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO
NWQ JAYCOX I-90, LLC TO ALLOW MAIN EVENT ENTERTAINMENT, LP
TO CONSTRUCT AN OUTDOOR PATIO LOCATED AT 35605 CHESTER ROAD
AND DECLARING AN EMERGENCY**

WHEREAS, NWQ Jaycox I-90, LLC (hereinafter referred to as NWQ) is the current owner of property located at 35605 Chester Road in the C-4 General Business District; and

WHEREAS, NWQ is in negotiations to sell said property to Main Event Entertainment, LP who will operate a family entertainment center known as “The Main Event”; and

WHEREAS, Main Event Entertainment, LP seeks to construct an outdoor seating area for patrons; and

WHEREAS, zoning regulations for the City of Avon require restaurants with outdoor seating areas in the C-4 General Business District to obtain a Special Use Permit pursuant to ACO §1280.05(bb); and

WHEREAS, NWQ, the current property owner, with the consent of Main Event Entertainment, LP, has submitted an application and presented plans and specifications for a 675 ft. outdoor seating area for the proposed restaurant to the Planning Commission on May 17, 2017; and

WHEREAS, the Planning Commission held a public hearing on May 17, 2017 and by a vote of Five (5) to Zero (0), recommended approval of the Special Use Permit; and

WHEREAS, the granting of this Special Use Permit requires approval of City Council; and

WHEREAS, Council, after reviewing the application, plans and specifications and the recommendation of the Planning Commission, deems it in the best interests of the health, safety and welfare of the community that the Special Use Permit be granted.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That having considered the matter of granting the Special Use Permit to NWQ, owner of property at 35605 Chester Road, to allow Main Event Entertainment, LP, to add an outdoor seating area to their restaurant, Council hereby accepts the recommendation of Planning Commission and agrees to grant said special use permit for a 675 sq. ft. outdoor seating area per the plans and specifications submitted and approved by the Planning Commission on May 17, 2017, and made a part of this Special Use Permit by reference but subject to the conditions set forth in this ordinance.

Section 2 - Conditions. 1) That soft, ambient music will be permitted on the outdoor seating area during periods when “The Main Event” is open to the public. Hours of operation are as follows: Monday, Friday and Saturday 9:00 a.m. to 2:00 a.m. and Tuesday, Wednesday Thursday and Sunday 9:00 a.m. to 12:00 a.m.; 2) That project proceed pursuant to plans and specifications approved and recommended by the Planning Commission at its May 17, 2017 meeting; and 3) that the Special Use Permit granted herein is conditioned upon applicant meeting all applicable requirements of the Avon Codified Ordinances including, but not limited to, 1280.02, 1280.03, 1280.05(bb), 1280.06(dd) and all sections requiring the enclosure of all outdoor storage. Any expansion, development, enlargement, improvement, change in ownership, tenancy, use or the like, other than maintenance of the property in its current condition, will require an additional amendment to this Special Use Permit, with a recommendation of Planning Commission and approval by Council.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to grant a Special Use Permit to NWQ to allow for the operation of a 675 sq. ft. outdoor seating area by Main Event Entertainment, LP; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
