

RESOLUTION NO. R-19-17

A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF AVON TO ENTER INTO AN AGREEMENT WITH THE LORAIN COUNTY OFFICE ON AGING FOR THE PROVISION OF SERVICES TO RESIDENTS OF THE CITY OF AVON AND DECLARING AN EMERGENCY

WHEREAS, certain senior citizens in the City of Avon meet the eligibility requirements and are in need of social services; and

WHEREAS, the Lorain County Office on Aging provides these seniors with various social services, not the least of which is the meals-on-wheels program, pursuant to a yearly agreement entered into with the City of Avon; and

WHEREAS, the time to renew said agreement has arrived and Council has reviewed the Agreement and Service Plan for the year 2017 and finds adoption of same to be in the best interests of the health, safety and welfare of the citizens of Avon.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the Avon City Council hereby authorizes the Mayor to enter into a renewal Agreement (Exhibit "A") with the Lorain County Office on Aging for the provision of social services to those residents of the City of Avon who meet eligibility requirements and are in need of those services for the year January 1, 2017 through December 31, 2017. Furthermore, Council hereby ratifies all actions taken by the Administration regarding the funding of the Lorain County Office on Aging for the years 2015 and 2016.

Section 2 – Said Agreement between Lorain County Office on Aging and the City of Avon shall state that the parties thereto shall conduct an annual audit of the services and service costs provided to the residents of the City and a monetary donation shall be made by the city to the Lorain County Office on Aging based on that review.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to authorize the Mayor to enter into a renewal Agreement and Service Plan (Exhibit "A") with the Lorain County Office on Aging and thereby timely provide important services to seniors without a break in said services in 2017; therefore, this Resolution shall be in full force and effect immediately upon its passage by this Council and approval by the Mayor.
