

ORDINANCE NO. 57-17

AN ORDINANCE AMENDING SECTION 1042.02(e)(1) OF THE CODIFIED ORDINANCES OF THE CITY OF AVON RELATING TO SEWER TAP FEES AND DECLARING AN EMERGENCY

WHEREAS, the City contracted with Jones & Henry Engineering to conduct a sanitary sewer rate study in December of 2013 to evaluate all of the City's rates and fees for this utility; and

WHEREAS, pursuant to that study it is necessary to increase tap fees for all taps 3 inches and greater; and

WHEREAS, it is necessary to amend Section 1042.02(e)(1) of the Codified Ordinances of the City of Avon to increase the cost of 3" taps and greater; and

WHEREAS, Council finds that these amendments to Section 1042.02(e)(1) of the Codified Ordinances is necessary to continue to provide, maintain and preserve the high levels of potable water service to the public all of which is necessary to protect the public peace, health, safety and welfare of the citizens of the City of Avon.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - It is necessary to amend Section 1042.02(e)(1) of the Codified Ordinances of the City of Avon to increase sanitary sewer tap connections fees which presently reads as follows:

1042.02 TAP-IN CHARGES.

(e) Tap-in Charges.

(1) There is hereby levied a sewer tap-in charge for each tap-in made to the sanitary sewerage system, to be paid to the City and deposited into Sanitary Sewer Fund No. 2, the funds from which shall be used for sewer debt reduction and/or for sewer operation and maintenance, and/or capital outlay, prior to the issuance of a building permit, if sanitary sewer service is available, or at the time that sanitary sewer service becomes available to a property owner, as follows:

Shall be amended to read as follows: (New language in **bold**)

1042.02 TAP-IN CHARGES.

(e) Tap-in Charges.

(1) There is hereby levied a sewer tap-in charge for each tap-in made to the sanitary sewerage system, to be paid to the City and deposited into Sanitary Sewer Fund No. 2, the funds from which shall be used for sewer debt reduction and/or for sewer operation and maintenance, and/or capital outlay, prior to the issuance of a building permit, if sanitary sewer service is available, or at the time that sanitary sewer service becomes available to a property owner, as follows:

Section 2 - Nothing herein shall be construed to eliminate the separate tap-in fees due directly to the City of North Ridgeville (French Creek Wastewater System) or the City of Avon Lake (Avon Lake Municipal Utilities) as set forth in this Chapter.

Section 3 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Ordinance were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of

Avon, the immediate emergency being the necessity to increase sewer tap-in fees on all taps; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
