

ORDINANCE NO. 18-18

AN ORDINANCE TO AMEND A SPECIAL USE PERMIT GRANTED TO CARAVON GOLF COMPANY, LTD (RED TAIL GOLF CLUB) TO INCLUDE CONSTRUCTION OF A 1,860 SQ. FT. EXTENSION OF EXISTING PATIO, INSTALLATION OF BOCCE COURTS, AND ORNAMENTAL FENCING LOCATED AT 4400 NAGEL ROAD AND DECLARING AN EMERGENCY

WHEREAS, Caravon Golf Company, Ltd., (Red Tail Golf Club), located at 4400 Nagel Road in an R-1 Residential District, operates a golf course, club house, tennis courts, swimming pool and other special uses at its facility pursuant to a Special Use Permit granted in Ordinance No. 54-99, passed May 10, 1999; and

WHEREAS, Council has passed Ordinance Nos. 69-10 and 100-15 to make amendments to that Special Use Permit; and

WHEREAS, it is again necessary to amend the Special Use Permit to include the construction of a 1,860 sq. ft. extension of the existing patio and installation of bocce courts and ornamental fencing located on the grounds of Red Tail Golf Course at 4400 Nagel Road; and

WHEREAS, the Planning Commission held a public hearing on February 21, 2018, and by a vote of Five (5) to Zero (0), recommended amending the Special Use Permit; and

WHEREAS, Council, after reviewing the application, plans and specifications and the recommendation of the Planning Commission, deems it in the best interests of the health, safety and welfare of the community that the amendment to the Special Use Permit be granted.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That Council hereby accepts the recommendation of the Planning Commission and amends the Special Use Permit for Caravon Golf Company, Ltd. (Red Tail Golf Club) to include the construction of a 1,860 sq. ft. extension of the existing patio and installation of bocce courts and ornamental fencing on the grounds of Red Tail Golf Course at 4400 Nagel Road, as per the plans and specifications submitted and approved by the Planning Commission on February 21, 2018 and made a part of this Special Use Permit by reference.

Section 2 - Conditions. 1) That the project proceed pursuant to plans and specifications approved and recommended by the Planning Commission on February 21, 2018; and 2) that the amended Special Use Permit granted herein for the construction of a 1,860 sq. ft. extension of the existing patio and installation of bocce courts and ornamental fencing is conditioned upon applicant meeting all applicable requirements of the Avon Codified Ordinances including, but not limited to those set forth in previous legislation (Ord. No. 69-10) in addition to the requirements of 1280.02, 1208.03, 1280.04(j) and 1280.06(n). Any other expansion, development, enlargement, improvement, change in ownership, use or the like, other than maintenance of the property in its current condition, will require an amendment to this Special Use Permit, with a recommendation of Planning Commission and approval by City Council.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend the Special Use Permit for Caravon Golf Company, Ltd., (Red Tail Golf Club) to include construction of a 1,860 sq. ft. extension of the existing patio and installation of bocce courts and ornamental fencing located on the grounds of Red Tail Golf Course at 4400 Nagel Road; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
