

ORDINANCE NO. 63-19

AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO AVON BREWING COMPANY, LLC TO ALLOW FOR THE CONSTRUCTION/INSTALLATION OF A 324 SQ. FT. OUTDOOR STORAGE FACILITY AT 37063 COLORADO AVENUE AND DECLARING AN EMERGENCY

WHEREAS, Mathias Hauck is the owner of property located at 37603 Colorado Avenue in the C-2 French Creek/Central Business District and is also the owner of Avon Brewing Company, LLC which operates a restaurant/brewery at said location; and

WHEREAS, zoning regulations for the City of Avon require businesses needing outdoor storage areas in the C-2 French Creek/Central Business District to obtain a Special Use Permit pursuant to ACO '1280.05(t); and

WHEREAS, the owner has submitted an application and presented plans and specifications for a 324 sq. ft. outdoor storage facility (beer cooler) for the business to the Planning Commission on June 19, 2019; and

WHEREAS, the Planning Commission held a public hearing on June 19, 2019 and by a vote of Five (5) to Zero (0), recommended approval of the Special Use Permit; and

WHEREAS, the granting of this Special Use Permit requires approval of City Council; and

WHEREAS, Council, after reviewing the application, plans and specifications and the recommendation of the Planning Commission, deems it in the best interests of the health, safety and welfare of the community that the Special Use Permit be granted.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That having considered the matter of granting the Special Use Permit to Mathias Hauck, owner of property located at 37063 Colorado Avenue and Avon Brewing Company, LLC, to add an outdoor storage (beer cooler) to their restaurant/brewery, Council hereby accepts the recommendation of Planning Commission and agrees to grant said special use permit for a 324 sq. ft. outdoor storage (beer cooler) per the plans and specifications submitted and approved by the Planning Commission on June 19, 2019, and made a part of this Special Use Permit by reference but subject to the conditions set forth in this ordinance.

Section 2 - Conditions. 1) That project proceed pursuant to plans and specifications approved and recommended by the Planning Commission at its June 19, 2019 meeting; 2) that the Special Use Permit granted herein is conditioned upon applicant meeting all applicable requirements of the Avon Codified Ordinances including, but not limited to 1270.03(d)(6), 1280.02, 1280.03, 1280.05(t), and 1280.06(w). Any expansion, development, enlargement, improvement, change in ownership, tenancy, use or the like, other than maintenance of the

property in its current condition, will require an additional amendment to this Special Use Permit, with a recommendation of Planning Commission and approval by Council.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to grant a Special Use Permit to the property owner at 37063 Colorado Avenue to allow Avon Brewing Company, LLC to construct/install a 324 sq. ft. of outdoor storage; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
