

RESOLUTION NO. R-7-20

A RESOLUTION TO ADVERTISE FOR BIDS FOR THE FRENCH CREEK ROAD PAVEMENT RESURFACING PROJECT AND DECLARING AN EMERGENCY

WHEREAS, due to normal wear & tear, increased traffic and expected disturbance from the upcoming Briar Lakes Pump Station Abandonment Project, it is necessary for the City to repair, and improve the pavement surface along French Creek Road within the municipality as noted on the attached Exhibit A during the 2020 construction season; and

WHEREAS, the City Administration has determined that French Creek Road should be improved based on inspection and recommendation of the Street Superintendent and the City Engineer; and

WHEREAS, the project shall consist of the following: Removal of the top portion of the existing pavement surface, full and partial depth pavement repairs at locations determined by the City Engineer, asphalt pavement surfacing, reinstallation of impacted pavement markings, maintenance of traffic, appurtenances thereto and associated restoration; and

WHEREAS, Council finds that it is in the best interest of the health, safety and welfare of the community that the City go forward with advertising for public bids to complete the French Creek Road Pavement Resurfacing Project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the Clerk of Council is hereby authorized and directed to advertise for bids for public improvements to French Creek Road. (See attached Exhibit A) Said improvements shall consist of the following: Removal of the top portion of the existing pavement surface, full and partial depth pavement repairs at locations determined by the City Engineer, asphalt pavement surfacing, reinstallation of impacted pavement markings, maintenance of traffic, appurtenances thereto and associated restoration. These improvements shall be made pursuant to plans and specifications developed by the City Engineer and Chagrin Valley Engineering, Ltd. which shall be on file and open for inspection at the Office of the Clerk of Council and incorporated herein by reference.

Section 2 - That the City shall reserve the right to reject any and all bids.

Section 3- That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4- That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to advertise for bids for the French Creek Road Pavement Resurfacing Project in order to facilitate substantial completion

prior to the end of 2020 construction season; therefore, this resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
