

RESOLUTION NO. R-30-21

**A RESOLUTION AUTHORIZING THE CITY TO ENTER INTO AN
AGREEMENT FOR TECHNICAL RESCUE RESPONSE
AND DECLARING AN EMERGENCY**

WHEREAS, the current Technical Rescue Response Contract, passed by Council on March 13, 2017 (Resolution R-10-17) will expire on December 31, 2021; and;

WHEREAS, it is now time for Council to extend the agreement for the Technical Rescue Response Contract for the period beginning January 1, 2022 and ending December 31, 2026; and

WHEREAS, Council has reviewed the proposed Agreement and finds that the mutual aid and cooperation being fostered by the Agreement between the various political subdivisions of Lorain County will better enable first responders to quickly mobilize for emergency situations and thereby further the health, safety and welfare of the residents of the City of Avon.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
AVON, LORAIN COUNTY, OHIO:**

Section 1 - That the City, through the Office of the Mayor, is hereby authorized to extend the Agreement for Technical Rescue Response for the period January 1, 2022 through December 31, 2026 and join with other political subdivisions of Lorain County in technical rescue planning and emergency response capabilities beneficial to the residents of the City of Avon. The Agreement, marked as [Exhibit A](#), is attached hereto and made a part hereof by this reference. The Finance Director is further authorized to increase the annual appropriation in Fire Department Fund No. 200 in the amount set forth in Exhibit A for each year of participation to satisfy the costs associated with this Agreement.

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to execute an Agreement with the County Board of Commissioners and other Lorain County political subdivisions to participate in, provide for and receive Technical Rescue Response services; therefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
