REVISION HISTORY:

PROJECT SCOPE:

This project consisted of the installation of approximately 5,934 feet of 8" sanitary sewers to service the properties along Elizabeth Avenue, Puth Drive, Joseph Street and a section of Detroit Road from 34008 Detroit to 34901 Detroit. It also included 3,879 feet of waterline replacement, miscellaneous storm sewer replacements, and pavement rehabilitation. The assessed portion of the project will only include sanitary sewer related items.
