

ORDINANCE NO. 25-22

AN ORDINANCE AMENDING SECTION 222.01 OF THE CODIFIED ORDINANCES OF THE CITY OF AVON REGARDING PLACES TO POST ENACTED LEGISLATION AND DECLARING AN EMERGENCY

WHEREAS, Section 222.01 of the Avon Codified Ordinances pertains to the posting of all ordinances, resolutions, statements, orders, proclamations and reports required to be posted by Article IV, Section 12 of the Charter of the City of Avon; and

WHEREAS, the City's Clerk of Council has reviewed Section 222.01 regarding the specific posting places currently being utilized by the City and recommends that Council bring it up-to-date with current practices; and

WHEREAS, Council, having reviewed the current list of posting places as well as the new list proposed by the Clerk of Council, finds that amending 222.01 to adopt the new list of posting places to be appropriate and in the best interests of the health, safety and welfare of the citizens of Avon in keeping them informed of the actions taken by City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN, AND STATE OF OHIO:

Section 1 - That Section 222.01 of the Codified Ordinances of the City of Avon currently states:

222.01 POSTING PLACES.

Pursuant to Article IV, Section 12, of the City Charter, the following places are hereby designated as posting places for the posting of all ordinances, resolutions, statements, orders, proclamations and reports required by law to be published or posted:

Shall be amended to read as follows: (Deleted language stricken. New language in bold print)

222.01 POSTING PLACES.

Pursuant to Article IV, Section 12, of the City Charter, the following places are hereby designated as posting places for the posting of all ordinances, resolutions, statements, orders, proclamations and reports required by law to be published or posted:

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend ACO '222.01 and designate a new posting location due to the imminent closure of Buck's Hardware; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
