

ORDINANCE NO. 126-22

**AN ORDINANCE AMENDING SECTION 222.01 OF THE CODIFIED
ORDINANCES OF THE CITY OF AVON REGARDING
PLACES TO POST ENACTED LEGISLATION
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Article IV, Section 12 of the Charter of the City of Avon, Council, in §222.01 of the Avon Codified Ordinances, lists all the posting locations for each ordinance, resolution, statement, order, proclamation and report it approves; and

WHEREAS, the 2022 Avon Charter Review Commission, in its final report, recommended to Council that it submit to the electors the question of amending Article IV, Section 12 of the City Charter to revise posting requirements; and

WHEREAS, pursuant to Article XIII, Section 7(b) of the City Charter, Council submitted to the electors a proposed amendment recommended by the Charter Review Commission and said amendment passed on November 8, 2022; and

WHEREAS, the City's Clerk of Council has reviewed Section 222.01 regarding the specific posting places currently being utilized by the City and recommends that Council amend said section to make it consistent with the newly amended City Charter provision; and

WHEREAS, Council, having reviewed the current list of posting places as well as the new Charter amendment, finds that amending 222.01 to adopt the new publication and posting places to be appropriate, consistent with language in the newly approved City Charter amendment and in the best interests of the health, safety and welfare of the citizens of Avon in keeping them informed of the actions taken by City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN, AND STATE OF OHIO:

Section 1 - That Section 222.01 of the Codified Ordinances of the City of Avon which currently states:

222.01 POSTING PLACES.

Pursuant to Article IV, Section 12, of the City Charter, the following places are hereby designated as posting places for the posting of all ordinances, resolutions, statements, orders, proclamations and reports required by law to be published or posted:

City Hall	36080 Chester Road
Avon Public Library	37485 Harvest Dr.
U.S. Post Office	36545 Detroit Road
Avon Senior Center	35785 Detroit Road
Discount Drug Mart	33552 Detroit Road

Shall be amended to read as follows: (Deleted language stricken. New language in bold print)

222.01 POSTING PLACES.

Pursuant to Article IV, Section 12, of the City Charter, the following are hereby designated as posting **methods and** places for the posting of all ordinances, resolutions, statements, orders, proclamations and reports required by law to be published or posted:

1. **Electronically** (City's website); and
2. **City Hall** 36080 Chester Road

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend ACO '222.01 and designate the new method and places of publication and posting; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

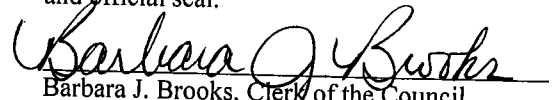
