

ORDINANCE NO. 138-22

AN ORDINANCE AMENDING COMPENSATION FOR THE POSITION OF PART-TIME, UNCLASSIFIED FACILITIES MAINTENANCE WORKER FOR THE CITY OF AVON AND DECLARING AN EMERGENCY

WHEREAS, in Ordinance No. 16-09, which passed on February, 9, 2009, City Council established the part-time, unclassified position of Facilities Maintenance Worker in Avon Codified Ordinance §256.04; and

WHEREAS, the Administration has reviewed the pay for that position and now recommends a pay range of between Twenty-Three Dollars (\$23.00) and Twenty-Eight Dollars (\$28.00) per hour, together with all other benefits of a permanent, part-time, non-bargaining unit employee of the City commencing with the date of hire through termination; and

WHEREAS, Council, in agreement with the recommendation of the Administration, finds adoption of the new compensation being proposed for the part-time, unclassified position of Facilities Maintenance Worker to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining a well-qualified, efficient and productive work force.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That effective with the passage of this Ordinance, the part-time, unclassified position of Facilities Maintenance Worker shall be paid an hourly rate of pay of between Twenty-Three Dollars (\$23.00) and Twenty-Eight Dollars (\$28.00) per hour, together with all other benefits of a part-time, unclassified, non-bargaining unit employee.

Section 2 - That the Finance Director is hereby authorized to appropriate funds necessary to meet the compensation established for this position as set forth in Section 1, above.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity of establishing compensation for the part-time, unclassified position of Facilities Maintenance Worker before the start of the 2023 pay period; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
