

ORDINANCE NO. 13-23

AN ORDINANCE TO AMEND THE COMPENSATION RANGE FOR THE UNCLASSIFIED, FULL-TIME POSITION OF CLERK OF CITY COUNCIL AND DECLARING AN EMERGENCY

WHEREAS, pursuant to Ordinance No. 42-16, which passed on April 11, 2016, Council established a range of compensation for the full-time, unclassified position of Clerk of City Council; and

WHEREAS, pursuant to Ordinance No. 134-22, which passed on December 12, 2022, Council increased the 2023 annual compensation for the position of Clerk of City Council to Seventy-Four Thousand, Nine Hundred, Sixty-Three and 20/100 Dollars (\$74,963.20); and

WHEREAS, Council, having reviewed the current pay rate, now recommends an amendment to Ord. 42-16 to increase the annual compensation range to between Sixty-Five Thousand and 00/100 Dollars (\$65,000.00) and Eighty-Five Thousand and 00/100 Dollars (\$85,000.00), together with all other benefits of a full-time, unclassified, non-bargaining unit employee of the City commencing with the passage of this Ordinance; and

WHEREAS, Council finds that adoption of the compensation range being proposed for the full-time, unclassified, non-bargaining unit employee position of Clerk of City Council to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining well-qualified, efficient and productive legislative personnel.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That effective with the passage of this Ordinance, the range of compensation for the full-time, unclassified, non-bargaining unit position of Clerk of City Council shall be set at an annual amount of between Sixty-Five Thousand and 00/100 Dollars (\$65,000.00) and Eighty-Five Thousand and 00/100 Dollars (\$85,000.00), together with all other benefits of a full-time, unclassified, non-bargaining unit employee of the City, and as directed by City Council. The compensation established in Ord. No. 134-22 for 2023 remains unchanged.

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity of amending the range of compensation for the Clerk of Council, a full-time, unclassified, non-bargaining unit employee; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
