

ORDINANCE NO. 16-23

**AN ORDINANCE ESTABLISHING A RANGE OF COMPENSATION FOR
THE UNCLASSIFIED, PART-TIME, POSITION OF ASSISTANT
CLERK OF CITY COUNCIL
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Ordinance No. 134-22, which passed on December 12, 2022, Council increased the 2023 hourly compensation for the permanent, part-time, unclassified Assistant Clerk of Council to Twenty-One and 63/100 Dollars (\$21.63) per hour; and

WHEREAS, Council, having reviewed this current hourly pay rate, now recommends establishing a range of compensation for this position of between Twenty and 00/100 Dollars (\$20.00) and Thirty Dollars (\$30.00) per hour and finds that adoption of this compensation range for the permanent, part-time, unclassified position of Assistant Clerk of Council to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining well-qualified, efficient and productive legislative personnel; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That effective with the passage of this Ordinance, the range of compensation for the permanent; part-time, unclassified position of Assistant Clerk of Council shall be set at an hourly rate of between Twenty and 00/100 Dollars (\$20.00) and Thirty and 00/100 Dollars (\$30.00) per hour, with hours not to exceed Thirty (30) hours per week, together with all other benefits of a permanent, part-time, non-bargaining unit employee of the City, and as directed by City Council. The compensation established in Ord. No. 134-22 for 2023 remains unchanged.

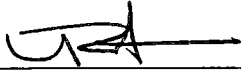
Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity of establishing a range of compensation for the permanent part-time, unclassified position of Assistant Clerk of Council; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

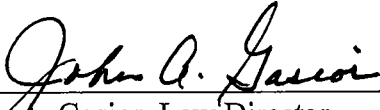

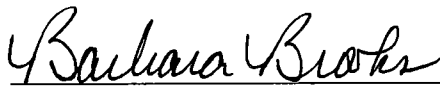
