

ORDINANCE NO. 17-23

**AN ORDINANCE TO ESTABLISH A RANGE OF
COMPENSATION FOR THE PART-TIME,
UNCLASSIFIED POSITION OF CITY TREASURER
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Ordinance No. 134-22, which passed on December 12, 2022, Council increased the 2023 annual salary for the permanent, part-time, unclassified City Treasurer to Twenty Thousand, Six Hundred, Eighty-Six and 65/100 Dollars (\$20,686.65); and

WHEREAS, Council, having reviewed this current salary, now recommends establishing a range of compensation for this salaried position of between Eighteen Thousand, Eight Hundred and 00/100 Dollars (\$18,800.00) and Twenty-Two Thousand, Eight Hundred and 00/100 Dollars (\$22,800.00) yearly, and finds that adoption of this compensation range for the permanent, part-time, unclassified position of City Treasurer to be reasonable and in the best interests of the health safety and welfare of the citizens of Avon in maintaining well-qualified, efficient and productive legislative personnel; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That effective with the passage of this Ordinance, the yearly salary range for the permanent, part-time, unclassified position of City Treasurer shall be set at between Eighteen Thousand, Eight Hundred and 00/100 Dollars (\$18,800.00) and Twenty-Two Thousand, Eight Hundred and 00/100 Dollars (\$22,800.00) together with any other benefits afforded a permanent, part-time, salaried, non-bargaining unit employee, and as directed by City Council. The compensation established in Ord. No. 134-22 for 2023 remains unchanged.

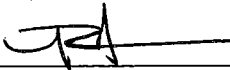
Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity of establishing a yearly range of salary compensation for the permanent part-time, unclassified position of City Treasurer; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

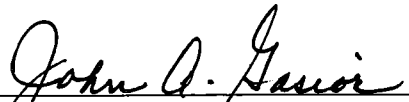

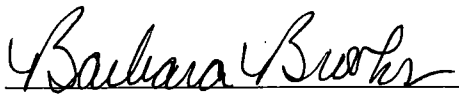

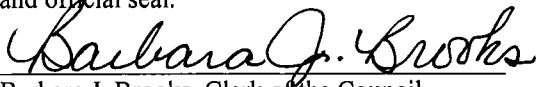
