

ORDINANCE NO. 42-23

**AN ORDINANCE TO AUTHORIZE THE MAYOR TO ENTER
INTO A CONTRACT WITH OES-SCOREBOARDS FOR THE PURCHASE
OF A SCOREBOARD MARQUEE SIGN AND APPURTENANCES
THERETO FOR THE CITY-OWNED CRUSHER STADIUM
AND DECLARING AN EMERGENCY**

WHEREAS, the Administration has determined that the scoreboard marquee sign and appurtenances thereto at Crusher's Stadium are in need of replacement; and

WHEREAS, OES-Scoreboards (hereinafter referred to as "OES") is an entity that sells and assembles scoreboards and appurtenances thereto to businesses and local governments; and

WHEREAS, the City's Service Director, together with the Finance Department have determined that OES pricing for the scoreboard marquee sign and appurtenances at Crusher Stadium to be fair and reasonable and recommends contracting with this company to replace the current scoreboard through the National Cooperative Purchasing Alliance (NCPA) of which the City is a member; and

WHEREAS, Council, based upon the recommendation of the Administration, finds that contracting with OES through the NCPA for the purchase of a new scoreboard marquee sign and appurtenances thereto presents the most cost effective approach to replacing the current scoreboard at Crushers Stadium and that doing so is in the best interest of the health, safety and welfare of the citizens of Avon in maintaining the Crusher Stadium as an attractive summer venue for residents of Lorain and surrounding counties.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That Council hereby authorizes the Mayor or the Finance Director to enter into a contract with OES-Scoreboards through the National Cooperative Purchasing Alliance (NCPA), a national cooperative purchasing group of which the City is a member (R-18-23), for the purchase of a new scoreboard marquee sign and appurtenances thereto for Crusher's Stadium.

Section 2 - Payment is to be made from the Stadium Highway Marquee Fund No. 284 pursuant to the directives of the Finance Director in the amount of Seven Hundred, Fifty-Six Thousand, Seven Hundred, Seventy-Three and 00/100 (\$756,773.00) Dollars.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Ordinance No. 42-23 (Con't)

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, Ohio, the immediate emergency being the necessity to enter into a contract with OES-Scoreboards through NCPA for the purchase and installation of a scoreboard marquee sign and appurtenances thereto for Crusher Stadium on or before the start of the 2023 Crusher's baseball season; therefore this Ordinance shall take effect and be in full force immediately upon its passage and approval by the Mayor
