

RESOLUTION NO. R-2-24

**A RESOLUTION TO ADVERTISE FOR BIDS FOR
THE LONG ROAD PAVEMENT RESURFACING PROJECT
AND DECLARING AN EMERGENCY**

WHEREAS, due primarily to normal wear and tear and increased traffic, it is necessary for the City of Avon to repair and re-pave Long Road during the upcoming construction season to maintain safe travel conditions for businesses, residents, and the traveling public; and

WHEREAS, the City Engineer has identified a Long Road Resurfacing Project from Detroit Road to Stoney Ridge Road, approximately 5,515 feet in total, including partial and full depth pavement repairs, minor pavement widening, and the complete asphalt resurfacing of the existing asphalt roadway within the project area; and

WHEREAS, Council finds that it is in the best interest of the health, safety and welfare of the Community that the City go forward with advertising for public bids to complete the Long Road Resurfacing Project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the Clerk of Council is hereby authorized and directed to advertise for public bids for the completion of the Long Road Pavement Resurfacing Project which will consist of the following: Removal of the top portion of the existing asphalt surface, partial and full depth asphalt pavement repairs at locations determined by the City Engineer, asphalt pavement resurfacing, minor pavement widening, reinstallation of impacted pavement markings, maintenance of traffic, and associated restoration all within the project area set forth in the attached [Exhibit A](#) which is incorporated herein by this reference. These improvements shall be made pursuant to plans and specifications developed by the City Engineer and Chagrin Valley Engineering, Ltd. which shall be on file and open for inspection at the Office of the Clerk of Council and incorporated herein by reference.

Section 2 - That the City shall reserve the right to reject any and all bids.

Section 3- That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4- That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to advertise for bids for the Long Road Pavement Resurfacing Project in order to facilitate completion prior to the end of 2024 construction season; therefore, this resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
